## January 8 - Bioscience / Life Sciences Program

**The Bioscience / Life Sciences Program** will include information that came from an Innovation Market Assessment that the Delaware Prosperity Partnership (DPP) recently conducted to evaluate the projected needs and opportunities in the biologics, life sciences, and advance chemicals community, with a specific focus on the need for "ready-to-go" lab space for growing companies.

The program will include some of the study's key findings and real estate opportunities for Delaware, especially as these companies "scale-up." Between the study and related follow up by the DPP, Delaware Technology Park, Delaware Innovation Space, and

the Delaware BioScience Association, local organizations are gathering data on the current and projected market needs for this type of real estate.

**Moderator Helen Stimson** (pictured here), Executive Director with **Delaware BioScience Association**, will lead the panelists to address what these companies are looking for and how the real estate/development community might address their needs to make sure they stay in Delaware. Panelists will include the President of Facility Logix, who conducted the study, and representatives from the local science and technology support organizations that will discuss the growing need for R&D space throughout the region.
